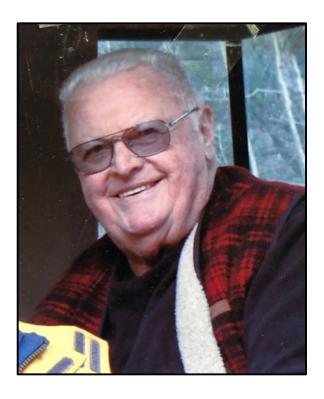

As we close on another busy fiscal year, we wish to thank the many dedicated people who work as elected officials, volunteers, and employees to keep the Town going. Without these individuals, the Town would have a hard time existing.

New Ashford partnered with West Field Gas and Electric for the implementation of High Speed Internet. Whip City Fiber is our Internet Service Provider. The majority of residents have service installed, with remaining installs taking place in the spring. This has been a long journey, but the rewards are great. Thanks to all involved in seeing this project through and making it happen. The new Internet Service has allowed our students to attend virtual classrooms and residents to work from home during this time of crisis.

At the time this report was written, there were 0 cases of Covid-19 in Town.

WE NEED VOLUNTEERS ASAP to keep our Fire Department operational, our town safe, and keep homeowner/business insurance costs under control.

The town will be begin planning for upcoming projects for the coming fiscal years. This list includes the following:

ANNUAL TOWN REPORT - THE NEW ASHFORD MUNICIPAL LIGHTING PLANT (FY20)

First and foremost, I would like to thank Jason Jayko, Lori Jayko, and Michelle Singer for their dedicated service in support of our High-Speed Broadband and official operation of The New Ashford Municipal Lighting Plant.

Since last year's report, 10.65 miles of fiber-optic cable has been installed on our town utility poles forming the physical New Ashford Municipal Network. Our network was certified and "lit" in September/October 2019. Our first residential installations commenced in October of 2019 and today we have 84 out of 115 (take rate of 73%) residences with High-Speed Broadband. At the time of this report, we have an estimated 5-6 residences that will take service in the May/June time frame.

For residents following the journey, our network without residential home connections was estimated at \$700,000 in FY2015.

I am proud to say, that our network along with the town covering the FY20 residential installation costs has cost the Town \$670,000 (this is final estimate as final known invoices are being received/paid). Of this \$670,000, \$280,000 was covered by the Mass EOHED Grant, and the remaining cost covered by the Town without raising FY20 or FY21 taxes for cost. Since 2011, the Town has incrementally built enough free cash/stabilization fund for the \$390,000 expenditure. \$346,812 was approved in the May 2019 annual town meeting and \$40,000 in February 2020 Special Town Meeting.

As previously communicated, any residence that does not take service by the end of FY20 (June 30, 2020), will be responsible for their respective connection/installation costs

For Free Cash/Stabilization restoration (which is still in good standing), we have (3) sources to replenish – these are all possible since our town achieved a 70% take rate, (well done New Ashford !!), the replenish sources near and short-term are as follows:

Now the New Ashford Municipal Lighting Plant (NAMLP) is an operational, not for profit utility, we must manage this as a successful business. The rate established of \$85 for Broadband Service was derived from a comprehensive estimate for all non-recurring, recurring, and operational expenses. As communicated in the last annual report, the Town of New Ashford had signed a contract with Westfield Gas and Electric (WG&E) on 02Jun2017 to design and construct New Ashford's Broadband Network. We have signed an additional contract for WG&E/WhipCity to manage and operate our network. There cost to manage/operate are low as WG&E is also not for profit municipal lighting plant. We are aligned in our mission for success and our relationship continues strengthen as we work together. Even though WG&E is doing all the management, the NAMLP is accountable and must manage and report accordingly. As you have seen, WhipCity is doing all the billing and collection and in turn, they transfer the received payment(s) to the NAMLP on a monthly basis. Table 1 is the Operational Summary through March 31, 2020.

The Council on Aging (COA) is funded by a grant from the State of Massachusetts. Volunteers meet to plan activities for Seniors in New Ashford. We also discuss services that are available to the Senior Community and provide information regarding these services through newsletters, Town Hall bulletin boards, and the Town website.

Over the past year members of the COA have:

- Started to compile contact information for Town residents over sixty years of age. This information includes address, email, and phone preferences. Our objective is to develop a means for contacting them regarding resources, support, activity interests and a continued awareness of what the Council on Aging is doing.
- Initiated a series of weekly yoga classes taught at Town Hall. The first set of sessions from October to December 2019 were such a success that we offered a second set of classes from January to February 2020. Classes were followed by light refreshments plus the opportunity to socialize with participants.
- Sent out newsletters which covered information on services, yoga classes, and the Real ID which is a new form of identification for travel, entering government buildings, and places where an ID is required.
- Been in contact with the MA Council On Aging, Age Friendly Berkshires, Elder Services of Berkshire County, MA Executive Office of Elder Affairs, and with other local COA's. This has provided us with resource information regarding the Coronavirus and support services available. Pertinent information has been disseminated to COA members, the Select Board & other senior residents that we were able to.
- A COA member continues to serve on the BRTA Advisory Board, representing the Town of New Ashford. Advisory Board meetings take place throughout the year.
- The Lanesboro COA received grant money to form a consortium between COA's in our area. It was decided that communication between towns plus exchange of resource information between COA's would better meet our needs. A consortium was not formed.

Tax Collector Annual Report

Real Estate:

FY2020 Real Estate taxes committed - \$479,398.98, with \$318,582.04 collected to date. Second half invoicing was mailed and due May 1, 2020. There were Abatement Exemptions in the amount of \$800.

Personal Property:

FY2020 Personal Property taxes committed - \$12,392.11, with \$8,735.01 collected to date. Second half invoicing was mailed and due May 1, 2020.

Excise Tax:

2020 – Commitment 1 of \$35,277.02, with \$26,397.27 collected, \$8,879.75 still currently due.

In February 2020, the decision was made to change the Deputy Collector. Billing is now handled by Kelley & Ryan Associates. They have been serving the needs of local and state governments for over 40 years. They also offer top-notch customer service and support for municipalities and individual taxpayers.

For individuals who have received an excise tax bill this year, you may have noticed a new service that is also available which is the convenience of paying excise tax bills online. Taxpayers using the site are charged a low convenience fee per transaction, not per bill (each charge can include multiple bills). A good number of residents have already taken advantage of this new service. Payments can still be mailed to the Tax Collector for processing.

With using this service, the town now has the Real Estate, Personal Property, and Excise Tax information in CollectPro, the software of Patriot Systems, that I have been using for several years. This also allows for ease of information transfer between the Tax Collector and the Assessor and helps us better serve the residents of New Ashford.

New Ashford Fire Department Annual Report

The New Ashford Volunteer Fire Department had a busy 2019. We responded to a total of 37 emergency calls: 14 Fire Calls, 19 Medical Calls, 3 Motor Vehicle Accidents, and 1 Mutual Aid Fire.

We had two members retire, Joe and Sue Nawazelski. If you see them, please thank them for their service to the town. The Department had 9 new members join: Lori Jayko, Stephen Jayko, Lily Jayko, Stella Jayko, Rich Moore, Liam Bettit, Dave Crosby, Tracy Crosby, and Matt Hoag.

We applied for two Assistance to Fire Fighters Grants (AFG) and were awarded both of them. The first grant replaced 13 of the Self Contained Breathing Apparatus (SCBA) for \$91,000, with brand new SCBA's. The second grant will replace the old tanker for \$230,000, \$215,000 from the grant and \$15,000 from the town's match. The new tanker will be delivered before 2021. We were fortunate to also get a regional grant from North Adams Fire for new turnout gear.

I would like to thank the Select Board for their support of the Department's efforts to get the grants, especially the tanker replacement. I would also like to thank all the members of the Department for their hard work and commitment to the Town for its safety and protection. Thank you to the townspeople who donate to the Department every year. Without your help, we would not be able to get essential equipment to help people in their time of need.

The Department has started a Junior Department for 14-18 year olds. If anyone is interested in joining either the Junior or Regular Department, please contact us.

Road Commissioner Report

This past year we finally repaved Beach Hill road. The existing road was reclaimed using full depth reclamation, graded, compacted and reinforced with 3.5" black top.

The ditches were re-established and cleaned, driveway entrances were graded to meet the new road surface. One new culvert was installed for access to a field.

Road-side "right of way" mowing took place in August thanks to the generosity of the Town of Dalton D.P.W

Water erosion problems on Greylock Rd. were addressed. Approximately 200ft. of ditch was excavated to keep water and ice buildup off the road.

Potholes were filled and any new ones will be filled in the near future.

A culvert failure on Bauer Road was replaced early this spring with road grating to follow.

The next road project will probably be Ingraham Road; repaving when funds are available.

For Calendar Year 2019, 834.99 tons of paper, glass, cans, and plastic were recycled District-wide. The Town of New Ashford recycled 4.01 ton of paper and 3.94 tons of glass, cans, and plastic, and increase from CY18. New Ashford's Scrap Recycling Program collected 7.41 tons of revenue for the Recycling Center of \$407.55, increasing your collection from last year – Congratulations! **Stephen DeMyer** was recognized at the District's annual meeting held July 2019 for his excellent service at the Recycling Center. Thank you for all you do!

Thank you to Richard & Stephen DeMyer, for providing Electronic Recycling collection for your residents. This recycling program was no cost to the residents to recycle. All e-waste was recycled through Goodwill of the Berkshires, Dell Computer Recycling program. New Ashford's Recycling Center has a new service, textile recycling. This will allow the residents to recycle clothing, shoes, textiles and keep them from entering the waste stream by donating whenever possible.

The District contracted with PSC/Stericycle for a one-day hazardous waste collection that was held on September 28, 2019 at the Adams DPW Yard. This location is central to the residents of the thirteen member towns and we appreciate the Town of Adams allowing NBSWMD the use of the property for that day. Residents from every member town, 154 households & 4 town departments in all, took advantage of the opportunity to dispose of hazardous chemicals in a safe way. The cost for this one-day event was \$9,101.50. Peace of mind for residents was "Priceless"! Thank you to the Town of Adams Commissioner & Selectman James Bush, Commissioner of Clarksburg, Carl McKinney & Commonwealth Community Service program & Adams Police Department for your help at our much-needed collection. The District has changed the paint collection program to mainstream the collection and maximize our dollars. Oil based paint is collected at the Comprehensive Household Hazardous Waste Collection, latex paint is no longer accepted as it is not a hazardous material. We continue to educate our residents on drying latex and proper disposal or donating if the product is usable.

The District has six Universal Waste Product Sheds for district member towns to utilize, funded throughout the years by Mass DEP. The cost of recycling is allocated from the District's yearly budget. This program has increased with collections. The sheds are at Adams, Cheshire, Hinsdale, Peru, Windsor, and Williamstown Transfer Station. NLR, Next Level for Recycling Inc designated facility for the districts recycling of Universal Waste products. To stay in compliance with Mass DEP, all sheds must be cleaned and packed for shipping on a yearly basis. Each town is generated a waste manifest, filed in the District office. Thank you again, to all who make this program a success. This program is also maintained by your Town's Transfer/Recycling Center Attendants. Thank you! The District recycled around 1,329 various sizes of fluorescent lamps, 230 alkaline batteries, 165 N-ICAD batteries, 180 lithium batteries costing \$2,483.11. We continue with outreach & education in assisting our communities in converting their households and businesses to LED lighting.

The District, with town volunteers, held annual bulky & electronic waste collection days in Adams, Clarksburg, and Lanesborough. The special collection events are open to all residents of the 13 member towns. Total material collected at Adams was 8,500 pounds of electronics, 3.02 tons of scrap metal, and 4.43 tons of furniture, etc. Total collected at Lanesborough was 2,200 pounds of electronics, 1.99 tons of scrap metal, and 2.87 tons of furniture, etc. Total collected at Clarksburg was 3,600 pounds of electronics, 2.87 tons of scrap metal, and 1.53 tons of furniture, etc. Thanks to our volunteers, Joe Szczepaniak, Selectman Sayers, Paul Howcroft, Selectman Bush, Scott & Daniel Cernik, & Adams, Clarksburg, & Lanesborough DPWs. The District had 3 very successful bulky waste collection events. The schedule for 2020 will be listed on our website and flyers will be available at the transfer stations as soon as dates are finalized. TBA at the District CHARM Center, more information to follow.

Yearly we partner with All Saints Church, North Adams, & sponsors for a community paper shredding event. Last year, the collection was September 28, 2019, a record-breaking community shredding event of between 11,000 - 13,000 pounds, according to ProShred. The collection promotes recycling and helps combat identity theft.

Please view our website for events and information/resources on recycling programs. Kick off to Earth Day/Month Community paper shredding day, Saturday April 11, 2020 in the Town of Lanesborough, open to all. Saturday, August 22, 2020, Household Hazardous Waste Collection to be held in Adams. The District has been in discussion with the City of North Adams in rejoining the District. Williams College, environmental studies conducted a comprehensive review on the pros and cons of the partnership. The conclusion was in favor of the City's rejoining. The study was presented to the City Council for consideration, a final decision is expected in February 2020.

This year NBSWMD Program Coordinator, Linda Cernik, filed grant applications and the Massachusetts Department of Environmental Protection awarded "Small Initiative Grants" of \$500.00 to five towns in the District & \$1,500.00 to NBSWMD. The Commissioners voted to pool the grants as a shared purchase of 700 14-gallon blue recycling bins, various outreach materials, community & schools & special collection events, community paper shredding days & HHW. The approved shared purchase will be a benefit to all the member towns and residents.

There were 8 towns in the District that received Mass DEP Recycling Dividends Program. Each of the member towns contributed \$500.00, with NBSWMD contribution of \$1,500.00 for shared purchase.

The towns of Adams, Cheshire, Hinsdale, Williamstown, Windsor and Savoy were again recognized and awarded funds under the Mass DEP Recycling Dividends Program. The District is proud to announce **two newcomers receiving Recycling Dividends Program**, Hancock & Florida. This program awards points for achievement. Awards for the District Member.

Towns: Adams \$4,200, Cheshire \$4,200, Florida \$2,800, Hancock \$2,450, Hinsdale \$4,900, Savoy \$3,500, Williamstown \$5,250, and Windsor \$4,200. The Towns of Clarksburg, Lanesborough, Monroe, **New Ashford**, and Peru were awarded Small Scale Awards of \$500 and NBSWMD \$1,500. Total **grants dollars awarded to NBSWMD \$35,500.** This is an increase of \$11,600 from last year's grant awards. Congratulations! We did it as a team, Thank you! The funds are reinvested to promote recycling education, new equipment, or projects. All the towns increased their RDP grant awards from last calendar year. My goal is to help all the towns achieve RDP Grant awards.

The waste stream continues to evolve, and our programs will continue to evolve as well. Our efforts in the coming year will be aimed at collecting textiles, expanding locations, Compost Distribution Program, creation of a new CHARM Center, waste reduction, negotiations for hauling and keeping cost down, Kick off the Earth Day/Month Community paper shredding event April 11, 2020, Household Hazardous Waste Collection scheduled August 22, 2020 in Adams, expanding our "Green Team" collaboration with our District Local Schools, outreach, and education.

A heartful thank you goes out to Shawn Wright, Amy Broderick, and Connor Doherty, The Commonwealth of Massachusetts Trial Court, and the Office of Community Corrections. Over **172 hours of volunteer time** were given to the member towns in the District. Your help with HHW Pick up, organizing the Town of Hinsdale's Swap Shop monthly cleaning, and organizing the Town of Williamstown's Book Shed. There are so many benefits from the Sheds at the Transfer Stations where many treasures can be found. Thank you for a great year and partnership!

Look forward to working with you in 2020!

The New Ashford Historical Commission Town Report 2019

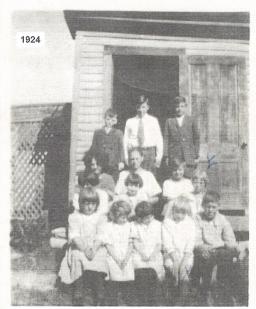
During the year 2019, the schoolhouse continues to be a focus for the New Ashford Historical Committee. Maintaining the building and grounds is an on-going commitment.

Micheal Nixon, an educator from Williamstown, led a group of local students who used the school as part of a summer program. The first photo is from Micheal Nixon's class in the summer of 2019. The second is the same setting, from our historical files.



In his words:

In the last week of August 2019 a group of nine school children attended a history drama program at the New Ashford schoolhouse. It was experiential learning where the school kids went back in time to around 1905. In period costume they used ink nib pens for script writing, practiced elocution, learned school etiquette, created stories for a local newspaper of that time, and studied some maps and related United States history. Lunch was replicated from foods of that time; that is, no plastic containers.

Another long term project was completed this year. A town flag was dedicated and hung in the Hall of Flags in the Capital building in Boston and in our town hall. The dedication in Boston at the state capital was attended by Representative John Barrett, and Senator Adam Hines, who extended support from his office to complete the project and organize the event. Also in attendance were members of the flag committee, the selectman, and Historical Committee members. It is the group's intent to sell flags to town residents for a fundraiser for future historical projects.

A third program in conjunction with the Historical Committee and the Williamstown House of Local History, is planned to commemorate New Ashford's historical place in the presidential election of 1920. The program will recognize the ratification of the 19th Amendment highlighting Pheobe Jordan, the first woman voter to exercise her voting responsibilities in the national election. Stay tuned.
