ANNUAL TOWN REPORT - THE NEW ASHFORD MUNICIPAL LIGHTING PLANT (FY21)

First and foremost, I would like to thank Jason Jayko, Lori Jayko, and Michelle Singer for their dedicated service in support of our High-Speed Broadband and official operation of The New Ashford Municipal Lighting Plant.

How was our town to know this high-speed broadband would be the life line for many of our residents during this global COVID-19 pandemic?

- 21 school students were able to virtually attend school safely from home from March 2020 to present
- Residents were able to work from home with reliable bandwidth that supported video conferencing for the most effective performance in the COVID environment complemented that multiple household users could simultaneously be online
- Allowed for effective virtual town governance
- Allowed our Fire Department and EMT to do online training in the COVID emergency
- Allowed many residents the ability to stream entertainment to have safe options during home isolation

As a reference, our first residential installations commenced in October of 2019 and today we have 90 out of 115 residences with High-Speed Broadband which represents a take rate of 78.2%.

The total project cost was \$660,938. We received \$322,500 in EOHED Grant Funds. The Town's contribution was \$338,438 to which \$139,594.49 was for the business and residential connection from the street utilities to premise; the remaining \$198,843.51 was allocated to the cost of installing the municipal network on the utility poles.

The \$338,438 was previously approved by Town vote for use of Free Cash/Stabilization dollars. This approval resulted in no impact to the Town Tax rate as well as no debt financing.

For Town Free Cash/Stabilization restoration, we have previously reported that we have (3) potential sources to replenish and cover costs – these are all possible since our town achieved a 70% take rate, (well done New Ashford !!), the replenish sources near and short-term are as follows:

As communicated in the last annual report, the Town of New Ashford had signed a contract with Westfield Gas and Electric (WG&E) on 02Jun2017 to design and construct New Ashford's Broadband Network. We have signed an additional contract for WG&E/WhipCity to manage and operate our network. The cost to manage/operate are low as WG&E is also not for profit municipal lighting plant. We are aligned in our mission for success and our relationship continues strengthen as we work together. Even though WG&E is doing all the management, the NAMLP is accountable and must manage and report accordingly. As you have seen, WhipCity is doing all the billing and collection and in turn, they transfer the received payment(s) to the NAMLP on a monthly basis. Table 1 is the Operational Summary through April 2021.

The NAMLP Enterprise Free Cash was certified for \$16,901 as reported in the 08 Feb 2021 MLP meeting minutes.

The New Ashford Municipal Lighting Plant (NAMLP) is an operational, not for profit utility, we must manage this as a successful business for continued viability. The rate established of \$85 for Broadband Service was derived from a comprehensive estimate for all non-recurring, recurring, and operational expenses.

We are operational for 1.5 yrs and we are awaiting the final reconciliation of WG&E invoices. We are in a favorable operational posture and are positioned for the final WG&E invoices and forecast no change to monthly rate.

It is my hope that the New Ashford Residents and businesses that have taken the NAMLP/WhipCity high-speed broadband service are very satisfied with the exceptional network installed. We have much better performance than the cable towns in Berkshire County.

2020 is the 100th anniversary of Phoebe Jordan's historic vote as the first women to vote in a presidential election after the ratification of the 19th Amendment. To honor this piece of town and United States history, our renovated school house was showcased for a program celebrating the 100th year anniversary of the ratification of the 19th Amendment.

On Monday, November 2, 2020 to commemorate this significant historical moment, The Historical Commission participated in a program sponsored by members of the League of Women Voters combined with the Williamstown Historical Museum and the New Ashford Historical Commission. An oral history, of Phoebe's life and her voting contributions, was filmed in the actual school house here in New Ashford where the notorious vote took place along with the actual ballot box as a back drop. The program recording is preserved by the Williamstown Historic Museum. It must be said that this was the year of COVID-19 which altered the original plans of a festive celebration in New Ashford. The event went virtual for safety reasons.

The historic schoolhouse was open to the public on voting day, and was opened for several viewings by request.

With future plans for research and building upkeep, this group is always welcoming volunteers.

Tax Collector Annual Report

FY2020 Real Estate taxes committed - \$479,398.98, with \$433,296.83 collected. Abatements of \$2,346.07 were issued.

FY2020 Personal Property taxes committed - \$12,392.11, with \$11,824.74 collected.

2020 Excise Tax – Commitment 1 of \$35,277.02, with \$31,745.16 collected, \$3,531.91 still due.

In February 2020, the decision was made to change the Deputy Collector. Excise Tax billing is now handled by Kelley & Ryan Associates. They have been serving the needs of local and state governments for over 40 years. They also offer top-notch customer service and support for municipalities and individual taxpayers.

For individuals who have received an excise tax bill this year, you may have noticed a new service that is also available which is the convenience of paying excise tax bills online. Taxpayers using the site are charged a low convenience fee per transaction, not per bill (each charge can include multiple bills). A good number of residents have already taken advantage of this new service. Payments can still be mailed to the Tax Collector for processing.

With using this service, the town now has the Real Estate, Personal Property, and Excise Tax information in CollectPro, the software of Patriot Systems, that has been used for several years. This also allows for ease of information transfer between the Tax Collector and the Assessor and helps us better serve the residents of New Ashford.

Tree Warden's Annual Report

Run Fact: National Arbor Day began in Nebraska in April of 1892. In MA is it celebrated on the last Friday of April. This year it falls on April 30.

FY21 was a slow year for tree work in town. We had only a couple calls for trees requiring removal on the town right-of-way and were fortunate enough to get Eversource to remove these trees at no cost to the town. I am still working to have several hazardous trees removed before the end of our fiscal year.

Namely: A Cherry tree at the cemetery, a large Oak overhanging the road on the south side of Ingraham and a grove of several Maples near 205 Mallery Rd.

Budget Summary

FY21 Tree Removal Budget: \$4400; spent to date: \$0 Projected Spending for FY21: \$4000

FY20 Tree Warden Budget: \$500; spent to date: \$0 Projected Spending for FY21: \$250

Activities performed this past year

- Coordination with Eversource to remove large, dead Silver Maple at 147 Mallery Rd.
- Coordination with Eversource to remove several dead/dying Maples along Smith Rd.
- Ongoing monitoring of Emerald Ash Borer activity via visual inspection of trees and inspection of EAB trap.
- Responded to several resident requests to look at suspect trees on Ingraham Rd (large cracked Oak)., Mallory Rd (several dead Maples) and a damaged Cherry at the Cemetery. RFQ's are out for removal of these trees.

Future Action Items

- 1. Removal of above-noted trees during FY21.
- 2. A Ash Borer trap will be placed in a Ash tree behind the Town Hall for this growing season. Please do not disturb it. The bait in the trap is simply RV antifreeze, so it is not hazardous or harmful.
- 3. Submit a proposal to plant new trees along the town right-of-way to replace recently removed trees.
- 4. Propose that New Ashford become a "Tree City USA", to be recognized by and receive benefits from the National ArborDay Foundation.

If you are aware of a tree in the public way that should be looked at for potential removal, please don't hesitate to call. I'll gladly come have a look. -Shaun

New Ashford Council On Aging

The Council On Aging (COA) is funded by a grant from the State of Massachusetts. Volunteers meet to plan activities for Seniors in New Ashford. We also discuss services that are available to the Senior Community and provide information regarding these services through newsletters, Town Hall bulletin boards, and the Town website.

Over the past year volunteer members of the COA have been covid compliant and socially distanced. We look forward to the time when we can safely resume activities. Despite restrictions:

- We continue to collect contact information from New Ashford senior residents, including postal and email addresses, and phone contact preferences. At present, we have received email messaging data from approximately 62% of New Ashford senior residents. We hope to expand to all email users in this group.
- We've taken steps to develop a "Blast" email capability. This will allow us to send timely and pertinent information to senior residents of New Ashford regarding available resources, support programs, activities, and updates on what the COA is doing.
- Due to the popularity of past Yoga classes, which were open to all residents, we have started to plan more classes for this Spring and Summer. The instructor has indicated a willingness to run indoor or outdoor classes. We will incorporate CDC COVID 19 recommendations for this type of activity. As in the past, classes will provide residents an opportunity to socialize with participants.
- We have maintained contact with the Massachusetts Council On Aging, of which we are a member, Elder Services of Berkshire County, Massachusetts Executive Office of Elder Affairs, and other local COA's. This has provided valuable resource information regarding the Coronavirus and support services available. Thus far this information has been disseminated by email, text, and word of mouth. In the future, we hope it will be distributed via the blast email capability mentioned above, as well as by US mail.
- A COA member continues to serve on the state transit BRTA Advisory Board, representing the Town of New Ashford.

If you have a suggestion for a Council On Aging activity or service, or you would like to provide us with contact information, please advise one of our members or send a note to Town Hall in care of the *Council On Aging*. If you would like to become a volunteer member, we welcome any resident.

NORTHERN BERKSHIRE SOLID WASTE MANAGEMENT DISTRICT Wide CY 20 Town of New Ashford

For Calendar Year 2020, District Wide Data 842.97 tons of paper, glass, cans, and plastic were recycled. The Town of New Ashford recycled 6.13 tons of paper and 3.82 Co-mingle. District Wide Recycling Services, MSW (Trash) 2,048 tons, Demo / Bulky recycling 649-ton, Scrap Metal Recycling 290 Tons generating revenue back to the Towns \$19,053. Congratulations to all the member Towns residents for increasing your recycling from last calendar year. The Textile Recovery recycling program District wide had an increase as well and collected 79,425pounds of textiles. Thank you for keeping from the waste stream and donating. The town's Transfer Station again this year rated Excellent in your MassDEP Third Party inspection. Congratulations to Transfer Station Attendants and town officials!

The District contracted with Clean Harbors Environmental for a one-day Hazardous Waste Collection that was held on August 22, 2020, at the Adams DPW Yard. This location is central to the residents of thirteen member towns and we appreciate the Town of Adams for allowing NBSWMD the use of the property for that day. Residents from every member town—155 households and several Town Departments in all—took advantage of the opportunity to dispose of Hazardous Chemicals in a safe way. The cost for this one-day event was \$10,150; Peace of mind for residents—Priceless! Thank you to Town of Adams Commissioner Edward Driscoll, Commissioner of Clarksburg Carl McKinney, Commonwealth Community Service program and Adams Police Department for help at our much-needed collection. The NBSWMD has changed the paint collection program to mainstream the collection and maximize our dollars. Oil-based paint is collected at the

Comprehensive Household Hazardous Waste Collection. Latex Paint is no longer accepted as it is not a hazardous material. We continue to educate of residents on drying latex and proper disposal or donating if the product is usable. Next Our HHW collection will be held April 24, 2021, Town of Adams DPW yard. Please view under <u>www.nbswmd.com</u>,

Under Special Collections.

The district has six Universal Waste Product Sheds for district member towns to utilize, funded throughout the years by Mass DEP. The cost of recycling is allocated from the district's yearly budget. This program has increased with the amount of collections and there are sheds at the Adams, Cheshire, Hinsdale, Peru, Windsor, and Williamstown transfer stations. Next Level for Recycling Inc. (NLR) is the designated facility for the district's recycling of Universal Waste products. To stay in compliance with Mass DEP all sheds must be cleaned and packed for shipping on a yearly basis. Each town generates a Waste Manifest which is filed in the district office. Thanks again to all who make this program a success. This program is also maintained by each town's transfer/recycling center attendants; thank you. The district recycled 917 LBS. Of various size Fluorescent lamps, 1088 LBS Mixed batteries, 503 LBS Non-PCB Contaminated Ballasts, 2 5 Gallon Containers of Mercury Devices (such as Thermostats and Thermometers) at a cost of \$4,655. We continue with outreach and education in assisting our communities in converting their households and Businesses to LED lighting. Please check with your local Community Action Council or Mass Save program. Your Utility Company can assist with this information regarding Energy Audits.

The district, with town volunteers, held annual Bulky and Electronic waste collection days in Adams, Clarksburg, and Lanesborough. The special collection events are open to all residents of the thirteen member towns. Total material collected at Adams: 14,230 pounds of electronics, 7.05 tons of scrap metal, and 5.61 tons of furniture, etc. Total collected at Lanesborough: 6120 pounds of electronics, 1.99 tons of scrap metal, and 1.51 tons of furniture, etc. Total collected at Clarksburg: 3600 pounds of electronics, 2.56 tons of scrap metal and 1.51 tons of furniture, etc. Thanks to our volunteers: Joe Szczepaniak, Paul Howcroft, Selectman Bush, Clarksburg, and Lanesborough DPWs. The district had 3 extraordinarily successful Bulky Waste Collection events. The schedule for 2021 can be found on our website (under special collections) and flyers will be available at the transfer stations as soon as dates are finalized. These collections are held in the months of June, September, and October.

The district April 11, 2020 offered with Pro Shred, paper shredding event; held at the Town Hall in Lanesborough. There was no cost for residents to utilize this collection, we generated 4,8000 PDS of shredded paper. The collection promotes recycling and helps combat identify theft. Many Towns residents had the opportunity to safely shred paper Documents.

Then introduce to all Member Towns in the District.

• July kicks off Town of Hinsdale TS promoting our subsidized Earth Machine Program (home composting units). Diverting food waste into Compost.

This year NBSWMD Program Coordinator Linda Cernik filed grant applications and the Massachusetts Department of Environmental Protection awarded "Small Initiative Grants" of \$500.00

to 3 towns in the district and \$1500.00 to NBSWMD. The Commissioners voted to pool the grants for a shared purchase of 100 (80) Gallon Earth Machines (home composting units), various outreach materials, and to organize special collection events by the community and schools and hold Community Paper Shredding days and HHW collection events. The approved shared purchase will be a benefit to all the member towns and residents. There were ten towns in the district that received Mass DEP Recycling Dividends Program. Each of the member towns contributed \$500.00, with NBSWMD contribution of \$1500.00 for shared purchase.

The Towns of Adams, Cheshire, Florida, Hancock, Hinsdale, Williamstown, Windsor, and Savoy were again recognized and awarded funds under the Mass. DEP Recycling Dividends Program. The district is proud to announce two newcomers receiving Recycling Dividends Program: towns of Monroe \$2800 and Peru\$3150 This program awards points for achievement. Awards for the district member towns: Adams \$5950, Cheshire \$4,550, Florida \$3500, Hancock \$3500, Hinsdale \$4,900, Savoy \$4550, Williamstown \$4900, and Windsor \$4550. Towns of Clarksburg, Lanesborough, New Ashford, and were awarded Small Scales Awards of \$500 and NBSWMD \$1,500 Total grants dollars awarded to NBSWMD: \$45,350 District wide. This is an increase of 30% from last year's grant awards. Congratulations, we did it as a team, thank you! The funds are reinvested to promote recycling education, new equipment, or projects. All the towns increased their RDP Grant Awards from last calendar year. My goal is to help all the towns achieve RDP Grant awards. Each year the criteria to achieve RDP Awards requires additional data and recycling requirements. This coming grant cycle all towns must certify that their school system is contracted with a hauling company which provides recycling. This data was captured in our Solid Waste and recycling data surveys submitted January 2021 for all 13 member towns.

The waste stream continues to evolve, and our programs will continue to evolve as well. Our efforts in the coming year will be aimed at expanding locations for collecting textiles; Compost Distribution Program; Pilot Program with Williams College. Creation of new CHARM Center; Waste reduction; keeping cost down, Kickoff to Earth Day/Month; HHW Collection April 24, 2021; and Community paper Shred Fest scheduled May 8, 2021, expanding our "Green Team" collaboration with our district's Local Schools, Outreach and Education.

A heartfelt thank you goes out to Shawn Wright and Amy Broderick and Connor Doherty, the Commonwealth of Massachusetts Trial Court, Office of Community Corrections. Over 168 hours of volunteer time were given to the member towns in the district. Your help—with HHW events, packing our Universal Waste Sheds, helping with special events, packing the boxes for pickup, organizing the Town of Hinsdale's Swap Shop monthly cleaning; and organizing the Town of Williamstown's Book Shed—is greatly appreciated. There are so many benefits from the sheds at the transfer stations. Many treasures can be found. Thank you all for a great year and partnership. We look forward to working with you in 2021!
