ANNUAL TOWN MEETING WARRANT
COVERING THE FISCAL YEAR 2022
BERKSHIRE COUNTY:

TO: ANY OF THE CONSTABLES OF THE TOWN OF NEW ASHFORD.

In the name of the Commonwealth of Massachusetts, you are required to warn and notify the inhabitants of the Town of New Ashford who are qualified to vote in the town affairs, to meet at the New Ashford Fire Station, 4 Ingraham Road, in said New Ashford, on Tuesday the Eighteenth of May 18, 2021 at 6:00PM, and transact the following business:

FIRST: To elect a Moderator for the following year.

SECOND: To see if the town will vote that there be levied on real estate and personal property of the town, or transferred from available funds, a sum sufficient to meet the appropriation of said meeting.

THIRD: To see if the town will vote to authorize the Select Board to retain counsel if necessary.

FOURTH: To see if the town will vote to close portions of Ingraham Rd, Roys Rd, Greylock Rd, Old Rte. Seven, and any other roads, that at certain times of the year the Road Commissioner and the Select Board deem necessary.

FIFTH: To see if the town will vote to authorize the Town Treasurer, with the approval of the Select Board, to borrow money, from time to time, in anticipation of the revenue of the fiscal year, beginning July 1, 2021, and to issue notes as may be given for a period of less than one year in accordance with chapter 44, section 17 of the Massachusetts General Laws.

SIXTH: To see if the town will vote to raise and appropriate the sum of Seven Hundred and Fifty-Eight Thousand, Three Dollars and Zero Cents (\$758,003.00) or any other sum, to defray the charges and expenses of the town of New Ashford, including any debts and interest and to compensate certain officers of the Town of New Ashford. (See attached sheet for individual line items)

SEVENTH: Enterprise Fund Budget To see if the town will vote to raise and appropriate the sum of Seventy-Seven Thousand, One Hundred and Twenty-Three Dollars and Three Cents (\$77,126.03) through user's fees and fund Three Thousand, Nine Hundred Dollars (\$3,900) to the General Fund to reimburse

shared Officer and Appointees Stipends, Electricity and Propane Cost. (See attached sheet for individual line items)

EIGHTH: To see if the town will vote to transfer from the Cash Stabilization Account, the sum in the amount Two Thousand, Five Hundred Dollars (\$2,500), to supplement the town's share of grant money from the FY 2022 budget for Emergency Management Grant. If the article is passed but the grant is not approved, the money will revert to the Cash Stabilization Account. (2/3 vote required)

NINETH: To see if the town will vote to appropriate and transfer from MLP Enterprise Fund Free Cash the sum of Four Thousand Dollars (\$4,000.00) to the Broadband Stabilization Fund or take any other action relative thereto. (Majority)

TENTH: To see if the town will vote to appropriate and transfer from Free Cash the sum of Two Hundred and Fifty Dollars (\$250.00) to the Old School House Repair Stabilization Fund or take any other action relative thereto. (Majority)

ELEVENTH: To see if the town will vote to appropriate and transfer from Free Cash the sum of Thirty-Five Thousand Dollars (\$35,000.00) to the Stabilization Fund or take any other action relative thereto. (Majority)

TWELVETH: To see if the Town will vote to set Fiscal Year 2022 spending limits for such revolving funds as follows.

THIRTEENTH: To see if the Town will vote to have its elected Cemetery Committee become an appointed Cemetery Committee for the Town of New Ashford; and if such vote passes by a simple majority, to instruct the Board of Selectmen to place on the ballot for the Annual Town Election being held May 2022, a ballot question to see if the residents of the Town of New Ashford will vote to have its elected Cemetery Committee become an appointed Cemetery Committee; or to take any other action in relation thereto.

FOURTEENTH: To see if the town will vote to appropriate and transfer from free cash the sum of Two Thousand, Seven Hundred Dollars, (\$2,700) for maintenance and repairs on Fire Department Engine 2. (Requires 2/3 majority vote)

FIFTEENTH: To see if the Town will vote to transfer the amount not to exceed Four Thousand and Three Hundred Dollars (\$4,300.00) from free cash for the Cost of Installation of Gas lines to Fire Department or take any action relative thereto. Requires 2/3 majority vote

SIXTEENTH: To see if the town will vote to rescind the borrowing authorization vote from May 19, 2015 for Four Hundred and Twenty Thousand Dollars (\$420,000.00) or take any other action thereto. The motion for this Article requires a simple majority vote.

Article Information - The purpose of this Article is to rescind borrowing authorizations previously approved by Town Meeting for various projects that have either been completed or are no longer necessary. The total amount of borrowing authorization that this Article seeks to rescind is Four Hundred and Twenty Thousand Dollars (\$420,000.00).

The only way to remove borrowing authorizations from the Town's financial records is by vote of Town Meeting.

SEVENTEENTH: To act thereon and conduct any business legally brought before said meeting.

You are hereby directed to serve this Warrant by posting three (3) attested copies thereof in public places in the Town of New Ashford, at least seven days before said meeting. Hereof fail not and make do your returns of doing to the Town Clerk at the time and place of the meeting afore said.
